Consider –

In our criminal justice system, the Government retains broad discretion as to whom to prosecute. So long as the prosecutor has probable cause to believe that the accused committed an offense defined by statute, the decision whether or not to prosecute, and what charge to file or bring before a grand jury, generally rests in his discretion.

Wayte v. United States, 470 U.S. 598 (1985) (vocal draft resister;
selective prosecution)

A prosecutor's power to damage or destroy anyone he chooses to indict is virtually limitless.

Irving Younger, *Memoir of a Prosecutor*, Commentary, Oct 1976 66-70.

(Federal prosecutor under Bobby Kennedy; federal district court judge; famous professor and evidence lecturer -- "10 Commandments of Cross" etc)
